

## CM DIVERSIFIED CREDIT LTD COMMUNIQUE

The Board of Directors of CM Diversified Credit Ltd (the “**Issuer**”) wishes to inform its noteholders and the public in general that it has approved on 9<sup>th</sup> June 2020 the following key amendments (the “**New Terms**”) to the terms of the listing particulars dated 14<sup>th</sup> June 2019 (“**Listing Particulars**”) pertaining to the secured credit-linked notes issued by the Issuer (the “**Notes**”). The New Terms shall, subject to regulatory approvals being obtained, be effective as from 29<sup>th</sup> June 2020.

In accordance with the terms of issue of the Notes, a Circular Notice shall be sent to noteholders.

CIEL Ltd, a 23% constituent of the Issuer’s portfolio, has requested that its noteholders provide it with a temporary technical waiver on certain covenants. The Circular Notice contains additional information regarding this waiver.

Noteholders shall have the right, upon receipt of the Circular Notice, to request and compel the Issuer to redeem, purchase or arrange for the purchase of, the whole or part of its Notes.
