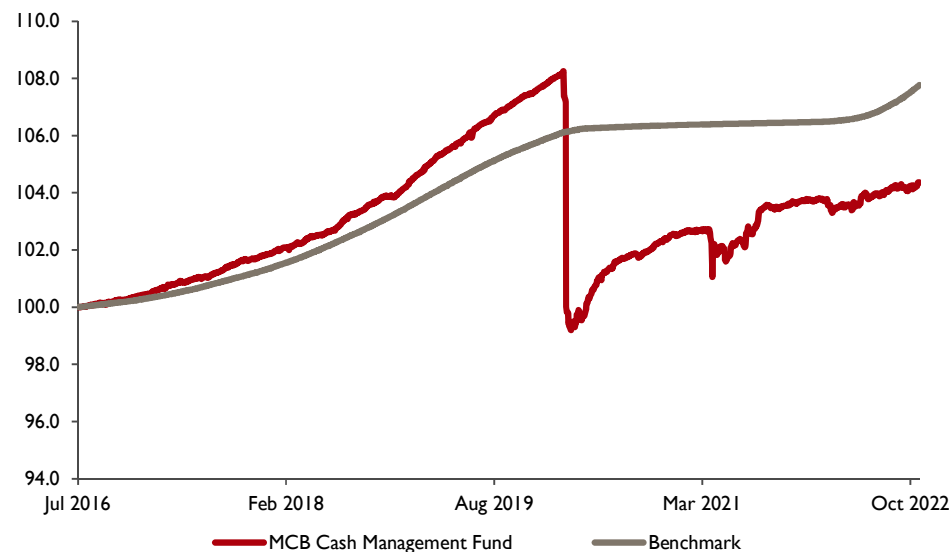
Investment Guidelines
