**Note 1:** Your vote counts. **Note 4:** The directors of the Company have resolved that, for the purposes of this Annual Meeting of Shareholders and in compliance with Section 120(3) of the Companies Act 2001, only the shareholders whose names are registered in the share register of the Company as at 31 October 2023 would be entitled to receive this Notice and would accordingly be allowed to attend and vote at such meeting.

**Note 6:** Resolutions I to XIV are proposed as ordinary resolutions, entailing that for each of the resolutions to be passed, more than half of the votes cast must be in favour of the resolution.

**Note 7:** Items 1 to 7 of the agenda are required to be considered and/or approved (where applicable) pursuant to section 115(4) of the Companies Act 2001.

**Note 8:** Appointment and remuneration of auditor. At every Annual Meeting of Shareholders (“AMS”), the Company is required to appoint an auditor to serve from the end of the AMS until the next AMS. Messrs. Ernst & Young have indicated that they are willing to continue as the Company’s auditor for the financial year 2023/2024. The Risk Management and Audit Committee of the Company has reviewed the auditor’s effectiveness and recommends that they hold office until the next AMS. Following normal practice, it is being proposed that the board of directors of the Company be hereby authorised to fix the auditor’s remuneration for the financial year 2023/2024.

**Note 9:** In accordance with The National Code of Corporate Governance for Mauritius (2016), the directors of the Company are submitting themselves for re-election. Biographical details and relevant skills of all directors are set out on pages 18 to 25 of the 2023 Annual Report and are also available on [www.rogers.mu](http://www.rogers.mu). The Board is satisfied that each of the directors standing for re-election continues to perform effectively and demonstrates commitment to his or her role in the long-term success of the Company.

**Note 10:** In accordance with The National Code of Corporate Governance for Mauritius (2016), the proxy report and voting results for this meeting will be published on the website of the Company on 30 November 2023 or as soon as reasonably practicable thereafter.

**Note 11:** In the event that this meeting cannot be held on 30 November 2023 due to (i) a cyclone warning class III or IV being in force in Mauritius; (ii) an extreme weather event<sup>1</sup>; (iii) heavy rain<sup>2</sup>; (iv) an intense tropical cyclone<sup>2</sup>; (v) a moderate tropical storm<sup>2</sup>; (vi) a severe tropical storm<sup>2</sup>; (vii) strong wind<sup>2</sup>; (viii) swell wave<sup>2</sup>; (ix) torrential rain<sup>2</sup>; (x) a tropical cyclone<sup>2</sup>; or (xi) a very intense tropical cyclone<sup>2</sup>; the meeting shall be postponed to a later date. The Board will communicate such date through the media.

<sup>1</sup>Pursuant to section 2 of The Mauritius Meteorological Services Act 2019, as amended from time to time, “extreme weather events”- (a) means tropical storm, tropical cyclone, heavy rain, torrential rain, flood, flash flood, high waves, storm surge and drought; and (b) includes any other weather condition likely to endanger life or property;
